## WITNESSETH THAT:

WHEREAS, the Secretary of Agriculture, United States Department of Agriculture, is authorized by the Watershed Protection and Flood Prevention Act to carry out a program of assistance to local organizations in planning and installing works of improvement for flood prevention or the conservation, development, utilization and disposal of water; and

WHEREAS, the Local Organization is cooperating in said program for the purpose of installing a project in the Bear Creek Watershed.

Watershed, State of Hissouri in connection with which it desires to secure certain rights, in, over and upon the hereinafter described land of the Landowner,

THEREFORE, for and in consideration of One Dollar (\$1.00) and the benefits accruing to the Landowner from the installation of said project, and other good and valuable considerations, the receipt whereof is hereby acknowledged, the Landowner does hereby grant, bargain, sell, convey and release unto the Local Organization an easement in, over and upon the following described land situated in the County of Sootland, State of Missouri , to wit:

The East three-fourths of the North half of the Southwest Quarter and the North half of the Southeast fourth of the Southwest Quarter, all in Section 13, Township 64, Range 10

for the purpose of:

For or in connection with the construction, operation, maintenance and inspection of the following described works of improvement to be located on the above described land; for the flowage of any waters in, over, upon or through such works of improvement; and for the permanent storage and temporary detention, either or both, of any waters that are impounded, stored or detained by such works of improvement: Works of Improvement to consist of stabilization structure D-2,5 and diversion as described in Bear Creek Watershed Project Plan.

- In the event construction on the above described works of improvement is not commenced within <u>eight years</u> from the date hereof, the rights and privileges herein granted shall at once revert to and become the property of the Grantor, his heirs and assigns.
- This easement includes the right of ingress and egress at any time over and upon the above described land of the Grantor and any other land of the Grantor adjoining said land.
- 3. There is reserved to the Grantor, his heirs and assigns, the right and privilege to use the above described land of the Grantor at any time, in any manner and for any purpose not inconsistent with the full use and enjoyment by the Grantee, its successors and assigns, of the rights and privileges herein granted.

- The Grantee is responsible for operating and mainteining the above described works of improvement.
- 5. Special provisions: Granter agrees to assume miner maintenance on works of improvement to include fence repair and moving of fill and emergency spillway as needed.

TO HAVE AND TO HOLD the aforesaid easement in, over and upon the above described land of the Grantor, with all the rights, privileges and appurtenances thereto belonging or in anywise appertaining, unto the Grantee, its successor and assigns, forever.
