



LAND DESCRIPTION:

A TRACT OF LAND BEING PART OF THE NORTHWEST QUARTER OF SECTION 20, TOWNSHIP 8 NORTH, RANGE 4 EAST OF THE FOURTH PRINCIPAL MERIDIAN, FULTON COUNTY, ILLINOIS AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS.

BEGINNING AT A FOUND IRON ROD MARKING THE NORTHWEST CORNER OF SAID SECTION 20; THENCE ALONG THE NORTH LINE OF SAID QUARTER, SOUTH 89 DEGREES 38 MINUTES 47 SECONDS EAST, 1312.00 FEET TO A SET IRON ROD; THENCE LEAVING SAID NORTH LINE, SOUTH 01 DEGREES 21 MINUTES 13 SECONDS WEST, 2277.35 FEET TO THE EXISTING CENTERLINE OF COUNTY HIGHWAY #24; THENCE ALONG SAID CENTERLINE, SOUTH 66 DEGREES 28 MINUTES 57 SECONDS WEST, 894.23 FEET TO THE INTERSECTION OF SAID CENTERLINE WITH THE SOUTH LINE OF SAID QUARTER; THENCE LEAVING SAID CENTERLINE, ALONG SAID SOUTH LINE, NORTH 89 DEGREES 45 MINUTES 16 SECONDS WEST, 313.96 FEET TO A SET IRON ROD; THENCE LEAVING SAID SOUTH LINE, NORTH 01 DEGREES 11 MINUTES 20 SECONDS EAST, 1363.64 FEET TO A FOUND IRON ROD; THENCE NORTH 86 DEGREES 50 MINUTES 36 SECONDS WEST, 179.07 FEET TO THE WEST LINE OF SAID QUARTER; THENCE ALONG SAID WEST LINE, NORTH 01 DEGREES 11 MINUTES 11 SECONDS EAST, 1267.36 FEET TO THE POINT OF BEGINNING.
