

A TRACT OF LAND BEING PART OF THE NORTHEAST QUARTER OF SECTION 36, TOWNSHIP 11 NORTH, RANGE 1 EAST OF THE FOURTH PRINCIPAL MERIDIAN, KNOX COUNTY, ILLINOIS, AND BEING MORE PARTICULARLY
