DESCRIPTION FOR 78.48 ACRE TRACT

A part of the NEV4 of Section 24, TI 3N, R4E of the 4th P.M., Knox County, Illinois. More particularly bounded and described as follows and bearings are for the purpose of description only:--

Commencing at an iron rod at the Southeast Corner of the NEI/4 of said Section 24; Thence N 89°55'31" W, along the South line of said NEI/4, a distance of I 331.27 feet to an iron rod and the Place of Beginning for the tract to be described; Thence continuing N 89°55'31" W, along said South line, a distance of I 309.11 feet to an iron rod at the Southwest corner of said NEI/4; Thence N 00°10'38" W, along the West line of said NEI/4, a distance of 2574.93 feet to an iron rod on the South line of a tract deeded to the State of Illinois for the right-of-way of Illinois Route #17; Thence N 62°24'16" E, a distance of 42.66 feet to an iron rod; Thence N 89°52'50" E, a distance of 328.08 feet to an iron rod; Thence S 00°07'10" E, a distance of 58.00 feet to an iron rod; Thence S 39°12'03" E, a distance of 60.00 feet to an iron rod; Thence N 50°47'57" E, a distance of 175.28 feet to an iron rod; Thence N 89°52'50" E, a distance of 236.22 feet to an iron rod; Thence S 79°52'16" E, a distance of 33.34 feet to an iron rod; Thence N 89°52'50" E, a distance of 87.96 feet to an iron rod; Thence with a curve turning to the left with an arc length of 212.02 feet, with a radius of 2065.93 feet, with a chord bearing of N 86°56'25" E, with a chord length of 211.93 feet; Thence N 78°47'13" E, a distance of 83.97 feet to an iron rod; Thence with a curve turning to the left with an arc length of 135.99feet, with a radius of 2060.00 feet, with a chord bearing of N 80°17'59" E, with a chord length of 135.97 to an iron rod. Beginning at an iron rod at the Southeast Corner of the NE¼ of said Section 24; Thence N 89°55'31" W, along the South line of said NE¼, a distance of 1331.27 feet to an iron rod; Thence N 00°10'00" E, a distance of 2648.73 feet to an iron rod on the South line of a tract deeded to the State of Illinois for the right-of-way of Illinois Route #17; Thence with a curve turning to the left along said right-of-way line, with an arc length of 9.37 feet, with a radius of 2060.00 feet, with a chord bearing of N 78°10'03" E, with a chord length of 9.37 feet, to an iron rod on the North line of said NE¼; Thence S 89°51'00" E, along said North line, a distance of 1318.21 feet to an iron rod at the Northeast corner of said NE¼; Thence S 00°10'00" W, along the East line of said NW¼, a distance of 2649.74 feet to the Place of Beginning and containing 81.01 acres, more or less. Subject to the right-of-way of a Public Road along the East side of the above described tract and also subject to all easements of record.
